## **ALLERGEN STATEMENT**

Regarding possible allergens in cosmetics, it is important to know what you are sensitive to and how to avoid it. Read ingredient labels, do your research, ask questions, and understand that an ingredient on the label may be derived from a material that may not be listed. For example, lecithin is commonly derived from soy. While Circadia lists all our ingredients on our packaging, and our website at **www.circadia.com/products**, its original source may not be. However, Circadia is always happy to answer questions about our ingredients.

Circadia has carefully evaluated our ingredients for the most common allergens, based on supplier information, however we have not tested our products for their presence. Therefore, if you have an allergy, please discuss the products with your doctor before using.

**Fragrance:** Our products are sold in Europe, and therefore have been evaluated for the presence of fragrance allergens which may be present in even natural botanical extracts. Circadia lists any fragrance allergens contained in the product at greater than 0.1%. They will be at the end of ingredients list (for example, Limonene).

**Gluten:** We have evaluated the ingredients currently used in our products to provide a list of possible glutencontaining ingredients derived from wheat, rye, barley and oats.

**Nuts:** Nut oils used in Circadia products are highly refined, and therefore not considered allergens. However, if you have a severe nut allergy, it is very important to check with your doctor before using any product containing nuts or nut oils. Circadia follows strict GMP guidelines for sanitization and raw material separation. We do not have a dedicated line for products containing nut oils. The following products contain tree nut oils: AquaPorin Hydrating Cream (Macademia nut oil); Nighttime Repair Lotion, Nighttime Repair Plus Lotion, Full Circle Night Cream, Vitamin A Boosting Cream (Peanut Oil); Amandola Milk Cleanser, Bright White Serum (Almond Oil).

**Natural rubber (latex):** Circadia skincare products contain no natural rubber or latex. However, the droppers of our 0.5 fl.oz. Hydralox bottles, contain natural rubber.

**Preservatives:** Circadia uses methylisothiazolinone (MIT), in one product: Nighttime Control Lotion. We are currently working to replace this with another preservative.

**Shellfish:** These Circadia products contain algae or other products from the sea.

We use a raw material in Revita-cyte Complex and SWiCH Fraction V that contains Microalgae Dunaliella Salina. According to the supplier of the material, it does contain fish or fish-by-products (though not shellfish), so we would advise against the use of Revita-cyte or Fraction V until the client discusses with their doctor.

The following products also contain a form of algae, however we have statements on file that none of these raw materials contain or have been produced on the same line as shellfish or fish.

Soybean: the following products contain a form of soy: AquaPorin Hydrating Cream, Firming Peptide Mask (soy protein); Hydralox Facial Oil, Vitamin Veil Cleanser, SWiCH Vitamin Veil Cleanser (soybean oil); Snow Algae & Spirulina Cooling Mask (soy lecithin/ soybean oil), Cocoa/Raspberry/Zymase Enzyme Masks (soy-derived monoglyceride); White Veil Brightener, Chrono Calm, Blueberry & White Tea Hydrating Mist, White Willow & Juniper Clearing Mist, Licorice & Bearberry Brightening Mist, Aloe & Calendula Calming Mist, Light Day SPF, MeriStem Serum (soy lecithin).

**Note:** The soybean oil and soy-derived-monoglyceride we use are highly refined. This process tends to destroy or remove the protein (the allergen), however, we cannot guarantee that there is 0% soy protein present in the final raw material.

- Daytime Control Lotion- contains Canadian Willowherb, a natural source of Salicylates, related to Salicylic acid)
- · Spot Stop Lotion (contains Camphor, Menthol, and Willow Bark, a natural source of salicins, related to Salicylic acid)

## 2. Products containing retinol or any form of A:

- · Vitamin A Boosting Cream
- · Vitamin A Gel
- · Nighttime Repair
- · Nighttime Repair Plus
- · Vitamin A Accelerator
- · Full Circle Eye Repair Night.
- **3. Nighttime Control** contains 5% benzoyl peroxide (may be used in limited amounts, consult with your doctor.
- **4. SWiCH Dermal Revitalization System**, due to its strength and activity
- **5. Professional Firming & Shaping Gel** contains caffeine and methyl nicotinate
- **6. Bright White Serum** there is not sufficient data on the effects of topical application during pregnancy of the brightening ingredient phenyl resorcinol. Discuss with your doctor.
